**Substance:** Ivermectin is a macrocyclic lactone derivative.  
Praziquantel is an acylated quinoline-pyrazine derivative.

### Section 2 - Hazards Identification

#### Statement of Hazardous Nature

This product is classified as: Not classified as hazardous according to the criteria of NOHSC Australia.  
Not a Dangerous Good according to the Australian Dangerous Goods (ADG) Code.

**Risk Phrases:** R52. Harmful to aquatic organisms.

**Safety Phrases:** S61. Avoid release to the environment. Refer to special instructions/Safety Data Sheets.

### Emergency Overview

**Physical Description & Colour:** White to off-white coloured paste.

**Odour:** Mild odour.

**Major Health Hazards:** no significant risk factors have been found for this product.

### Potential Health Effects

#### Inhalation

**Short Term Exposure:** Significant inhalation exposure is considered to be unlikely. Available data indicates that this product is not harmful. In addition product is unlikely to cause any discomfort or irritation.

**Long Term Exposure:** No data for health effects associated with long term inhalation.

#### Skin Contact:

**Short Term Exposure:** Available data indicates that this product is not harmful. It should present no hazards in normal use. However product is believed to be mildly irritating, but is unlikely to cause anything more than mild transient discomfort.

**Long Term Exposure:** No data for health effects associated with long term skin exposure.

#### Eye Contact:

**Short Term Exposure:** Exposure via eyes is considered to be unlikely. This product is believed to be mildly irritating, to eyes, but is unlikely to cause anything more than mild transient discomfort.

**Long Term Exposure:** No data for health effects associated with long term eye exposure.

#### Ingestion:

**Short Term Exposure:** Significant oral exposure is considered to be unlikely. This product, while believed to be not harmful, is likely to cause headache and gastric disturbance such as nausea and vomiting if ingested in significant quantities. This product is unlikely to cause any irritation problems in the short or long term.

**Long Term Exposure:** No data for health effects associated with long term ingestion.

#### Carcinogen Status:

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

### Section 4 - First Aid Measures

#### General Information:

You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this MSDS with you when you call.

**Inhalation:** First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor.

**Skin Contact:** Blot or brush away excess product. Wash gently and thoroughly with water (use non-abrasive soap if necessary) for 10 minutes or until chemical is removed. Under running water, remove contaminated clothing, shoes and leather goods (e.g. watchbands and belts). If irritation persists, repeat flushing and obtain medical advice.

**Eye Contact:** Quickly and gently blot or brush product away. Flush the contaminated eye(s) with lukewarm, gently flowing water until the product is removed or until irritation has ceased, while holding the eyelid(s) open. Obtain medical advice if irritation becomes painful or lasts more than a few minutes.

**Ingestion:** If nausea or gastric upset develops, remove individual to rest area and monitor. If symptoms get worse or if individual becomes distressed, contact the Poisons Information Centre or a doctor.

### Section 5 - Fire Fighting Measures

**Fire and Explosion Hazards:** There is no risk of an explosion from this product under normal circumstances if it is involved in a fire. Violent steam generation or eruption may occur upon application of direct water stream on hot liquids.

Fire decomposition products from this product may be toxic if inhaled. Take appropriate protective measures.

**Extinguishing Media:** Preferred extinguishing media are carbon dioxide, dry chemical, foam, water fog.

**Fire Fighting:** When fighting fires involving significant quantities of this product, no special precaution is believed to be necessary.

**Flash point:** Not flammable.

**Upper Flammability Limit:** No data.

**Lower Flammability Limit:** No data.

**Autoignition temperature:** No data.

**Flammability Class:** No data.

### Section 6 - Accidental Release Measures

**Accidental release:** This product is sold in small packages, and the accidental release from one of these is not a cause for concern. For minor spills, refer to product label for specific instructions.

The following measures are meant for incidents involving large quantities such as pallet loads which may be shipped from the manufacturing site to the warehouse or within the warehouse itself.

In the event of a major spill, prevent spillage from entering drains or water courses. Wear full protective clothing including eye/face protection. All skin areas should be covered. See below under Personal Protection regarding Australian Standards relating to personal protective equipment. Suitable materials for protective clothing include rubber, PVC. Eye/face protective equipment should comprise as a minimum, protective glasses and, preferably, goggles. If there is a significant chance that vapours or mists are likely to build up in the cleanup area, we recommend

that you use a respirator. Usually, no respirator is necessary when using this product. However, if you have any doubts consult the Australian Standard mentioned below (section 8).

Stop leak if safe to do so, and contain spill. Absorb onto sand, vermiculite or other suitable absorbent material. If spill is too large or if absorbent material is not available, try to create a dike to stop material spreading or going into drains or waterways. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. Recycle containers wherever possible after careful cleaning. Refer to product label for specific instructions. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. Full details regarding disposal of used containers, spillage and unused material may be found on the label. If there is any conflict between this MSDS and the label, instructions on the label prevail. Ensure legality of disposal by consulting regulations prior to disposal. Thoroughly launder protective clothing before storage or re-use. Advise laundry of nature of contamination when sending contaminated clothing to laundry.

### Section 7 - Handling and Storage

**Handling:** Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. Check Section 8 of this MSDS for details of personal protective measures, and make sure that those measures are followed. The measures detailed below under "Storage" should be followed during handling in order to minimise risks to persons using the product in the workplace. Also, avoid contact or contamination of product with incompatible materials listed in Section 10.

**Storage:** This product is a Scheduled Poison. Observe all relevant regulations regarding sale, transport and storage of this class of poison. Store in the closed original container in a dry, cool (below 30°C), well-ventilated area out of direct sunlight. Make sure that the product does not come into contact with substances listed under "Incompatibilities" in Section 10. Check packaging - there may be further storage instructions on the label.

### Section 8 - Exposure Controls and Personal Protection

The following Australian Standards will provide general advice regarding safety clothing and equipment:

Respiratory equipment: **AS/NZS 1715**, Protective Gloves: **AS 2161**, Industrial Clothing: **AS2919**, Industrial Eye Protection: **AS1336** and **AS/NZS 1337**, Occupational Protective Footwear: **AS/NZS2210**.

Exposure limits have not been established by NOHSC for any of the significant ingredients in this product.

The ADI for Ivermectin is set at 0.001mg/kg/day. The corresponding NOEL is set at 0.1mg/kg/day.

The ADI for Praziquantel is set at 0.02mg/kg/day. The corresponding NOEL is set at 20mg/kg/day. ADI means Acceptable Daily Intake and NOEL means No-observable-effect-level. Values taken from Australian ADI List, Dec 2003.

No special equipment is usually needed when occasionally handling small quantities. The following instructions are for bulk handling or where regular exposure in an occupational setting occurs without proper containment systems.

**Ventilation:** No special ventilation requirements are normally necessary for this product. However make sure that the work environment remains clean and that vapours and mists are minimised.

**Eye Protection:** Eye protection is not normally necessary when this product is being used. However, if in doubt, wear suitable protective glasses or goggles.

**Skin Protection:** The information at hand indicates that this product is not harmful and that normally no special skin protection is necessary. However, we suggest that you routinely avoid contact with all chemical products and that you wear suitable gloves (preferably elbow-length) when skin contact is likely.

**Protective Material Types:** There is no specific recommendation for any particular protective material type.

**Respirator:** Usually, no respirator is necessary when using this product. However, if you have any doubts consult the Australian Standard mentioned above.

**Incompatibilities:** strong acids, strong bases, strong oxidising agents.

**Fire Decomposition:** Carbon dioxide, and if combustion is incomplete, carbon monoxide and smoke. Water. Carbon monoxide poisoning produces headache, weakness, nausea, dizziness, confusion, dimness of vision, disturbance of judgment, and unconsciousness followed by coma and death.

**Polymerisation:** This product will not undergo polymerisation reactions.
